The Lieutenant-Governor in Council:

The undersigned has the honour to report

o/c 2898/50
THAT the Shawnigan Improvement District is an improvement district under the Water Act and was constituted by Letters Patent issued on October 27, 1950.

THAT the Trustees of the said District and the owners of the lands hereinafter described have petitioned to have the letters Patent of the District amended to include the said lands within the tract of land comprising the District.

THAT it appears in the public interest to grant the prayer of the said petitioners.

AND TO RECOMMEND:

THAT in accord with Section 51 of the Water Act, being Chapter 361 of the Revised Statutes of British Columbia 1948, the Letters Patent of the Shawnigan Improvement District be amended to include within the tract of land comprising the said District certain lands in the Shawnigan Land District and the Victoria Land Registration District more particularly described as follows:

- Parcel A of Section 3 excepting Registered Plan 189R;
- Part Section 2 lying west of Cobble Hill Road excepting south 5 chains; Lot 4 of Section 2 Registered Plan 9679;
- Parcel B of Section 1; Lots 1, 2 and part Lot 3 lying north west of road, Registered Plan 2132 of Section 3;
- Lot 1, Registered Plan 5172 of Section 2 except Registered Plan 9679; south half of Section 4; Section 3 excepting south 12 chains and part lying south east of Registered Plan 1042 OS; Section 5 and the north half of Section 4; all the aforementioned being within Range 7.
- Section 2 except parcel B, Section 5, west half Section 7 and Section 4 of Range 6.

THAT certified copies of this order, if approved, be furnished the Shawnigan Improvement District, c/o G.R. Hamilton, Secretary, Shawnigan Lake, B.C., the Surveyor of Taxes, Department of Finance, Parliament Buildings, Victoria, B.C. and the Registrar for the Victoria Land Registration District, Victoria, B.C.


